



# CODE OF CONDUCT

***We at Pregnancy Care Centers of Chandler and Gilbert ("PCC") thank you for your desire to share in this ministry as we meet the physical, emotional and spiritual needs of our clients experiencing crisis pregnancies. Without you as a well-trained Volunteer/Board of Director, we would not be effective in this outreach.***

1. I agree with and have signed the PCC Statement of Faith and Principal. As a Volunteer/Board of Director who has accepted Jesus Christ as my Savior and Lord, and who is attending a home church consistently and regularly, I believe that I can minister to women in crisis pregnancies regardless of race, creed, nationality, age or marital status.
2. I promise to live within biblical standards of sexual conduct. As a single person, I will live an abstinent lifestyle and state that I have been abstinent during the past six months. As a married person, I will not participate in extra-marital sex. I believe that marriage is strictly defined as the union between one man and one woman.
3. If I have experienced an abortion, I will comply with the Director's assessment of my need for post abortion counseling.
4. I am in complete agreement with the policies of PCC, including not referring for abortion. I will continue to minister to the client's needs regardless of her decision.
5. I promise to minister to each client with the wisdom, knowledge and love of the Lord. I will help each client to be responsible for her actions and to plan constructively for the future. All information on PCC Chandler and Gilbert clients will be kept in the strictest confidence. I will continue to keep the information confidential even after I am no longer a Volunteer/Board of Director for PCC.
6. I will strive to convey to each client that I am more concerned about her than her decision. I will present the facts and let the facts speak for themselves. Through Christ, I will express His love and offer His forgiveness to our clients by word and actions.
7. I will do everything in my power to continue with a client through her pregnancy until all needs are met or until she is transferred to another counselor, should that be appropriate.
8. I will not participate in any abortion clinic activism (picketing, sidewalk counseling or acts of civil disobedience), as I understand this may adversely affect the relationships with center clients. This policy does not limit participation in other political activities during their own time, including participation in peaceful pro-life marches.
9. As a Volunteer I will, with God's help, commit to a minimum of one (1) year to PCC Chandler and Gilbert ministry or as Director on Board, as outlined in the Bylaws. I will be dependable, responsible and faithful to my time commitment. I will provide adequate notice if I am unable to be at PCC Chandler and Gilbert for my shift. I will make every effort to attend required training, and if absent I commit to be responsible to obtain the information missed.
10. I will serve wherever I am needed at any PCC location. I will be prayerful, open to the Holy Spirit and opportunities to share the Gospel of Christ, whenever possible. I will observe the mandates of PCC of Chandler and Gilbert. I will keep abreast of the times by reading literature about issues involving women in crisis pregnancies.
